



## OUTSTANDING STUDENT ORGANIZATION ADVISOR AWARD

The Hobson Memorial Union annually recognizes the dedication of student organization advisors with its Outstanding Student Organization Advisor Awards. We are seeking nominations of qualified individuals to be presented with this award at the Leadership Awards Ceremony.

### Eligibility:

1. The nominated individual must serve as the official student organization advisor to a BSU recognized student organization.
2. The nominated individual must perform their advisory duties as a volunteer and not as part of their job description.
3. The student organization must be a recognized student organization in good standing with Bemidji State University.

### Criteria:

Selected recipient(s) must exhibit the following qualities:

1. Display a genuine concern and commitment to the organization(s) they advise.
2. Effectively motivate members to perform to their fullest potential within the organization.
3. Serve as a resource for the student organization as an official representative for the university.
4. Provide significant service to the campus through outstanding achievements.
