Article 25, Section E. Non-Renewal of Probationary Faculty

Summary: Excepting all contractual, legal, and criminal provisions, the IFO agreement *generally* provides a newly appointed probationary faculty member with a *minimum* of two years of probationary employment prior to dismissal through the non-renewal process.

In any probationary year after the date of November 1 in a Probationary Faculty's second probationary year, a notification of non-renewal must occur no later than August 1, with employment allowed through the subsequent academic year.

A Probationary Faculty entering their second year of a probationary position and recommended for non-renewal must be notified of non-renewal no later than November 1 of their second year of probationary employment and allowed employment through the remainder of their second academic year.
