


Figure 2. Number of states with one to five or more ways to meet the rigorous curriculum requirement for the ACG: 2006–07








Likelihood os ACG Receipt by Race and Class Category by Year




Frequency of ACG Receipt by Gender and Class Category by Year



Likelihood of ACG Reciept by Gender and Class Category by Year




Frequency of ACG Receipt by Parental Education Level and Class Category by Year







Frequency of ACG Receipt By Field of Study and Class Category by Year




Likelihood of ACG Reciept by Field of Sudy and Class Category by Year
