

### Addictions Internship Learning Goals Guide

### **Suggested Guidelines for Use**

- 1. During the first few sessions of supervision, take a moment to review the Learning Goals Guide and highlight during the internship process when the tasks in each 12 core function will be completed.
- 2. Interns/field instructors may use the "Tasks" column to indicate what tasks at the agency will be completed to demonstrate competency.
- 3. The "Date Added" column may be used to indicate what date the field instructor/intern begins observing/completing the task and the "Date Completed" may be used to indicate the date the task has been completed.

### **Competency 1: Screening**

4E	Develop a diagnostic evaluation of the client's substance abuse and any coexisting conditions based on the results of all assessments to provide an integrated approach to treatment planning based on the client's strengths, weaknesses, and identified problems and needs.

6D	Individualize counseling in accordance with cultural, gender, and lifestyle differences.			
6E	Interact with the client in an appropriate and therapeutic manner.			
6F	Elicit solutions and decisions for the client.			
6G	Implement the treatment plan.
