  - *Elementary (K-6) license candidates must have field experience in both the lower (K-2) and upper (3-6) elementary levels.*
  - *5-12 license candidates must have field experience in middle school (5-8) and high school (9-12).*
  - *K-12 license candidates must have field experience in elementary (K-6), middle school (5-8), and high school (9-12).*
- *Teacher candidates must complete all field experience hours required for each of their courses. If candidates are completing more than one licensure program, they must have a minimum of 30 hours of field experience in each of their licensure areas.*
- *Due to COVID restrictions, candidates completing field experience in certain semesters were allowed to complete some alternative field experience hours as non-student direct contact hours (NSDCH). Only 50 of a candidate's required field experience hours can be NSDCH hours.*
- *Any field experience logs not recorded in SL&L should be submitted with this verification form.*
